Sales names and model names

All sales names used in the marketing of the product and the regulatory model name must be registered on the certificate. The sales name is the most unique name the brand owner uses to identify the product in marketing (for example, on the website). No wildcards are allowed in sales names.

Range of a certificate

- Only one model name may be placed on each certificate, but it may have up to 2 wildcards as long as a type key
 explaining the options for the wildcards is provided.
- Several sales names may be placed on the same certificate.

Hardware limitations on the same certificate

 All products on the same certificate must share the same display, size aspect ratio, resolution and chassis appearance (except for types of ports and color differences).

Annual fee

The TCO Certified certificate is valid for two years, and the TCO Certified Edge certificate is valid for one year. After that period, the validity period can be extended subject to an <u>annual</u> fee. If a certificate is not prolonged, it will be canceled and archived when it expires. To prolong an archived certificate, an opening fee of 1,000 EUR is charged

Range of a certificate

• Several regulatory model names may be placed on the same certificate as long as they are all marketed under one sales name.

Hardware limitations on the same certificate

- All products on the same certificate must share the same chassis appearance (except for types of ports and color differences).
- For headset products, all products on a certificate must be either wired or wireless, and share the same chassis appearance (except for stereo, mono, color or headband).

All invoices must be settled within 45 days of the invoice date, Late payments will result in a fee of 250 EUR per invoice to cover the administrative costs associated with late payments.

The penalty fee referred to in clause 12 of the General Terms of the TCO Certified License Agreement is EUR 20,000.

The sub-licensing fee referred to in clause 2.2 of the General Terms of the TCO Certified license agreement is EUR 5,000/year. (This fee is charged once every year for the sub-licensing agreement between a brand and TCO Development and it covers an unlimited amount of certified products sub-licensed during that year.)
